I am directed to refer to the above mentioned subject and to say that the representation dated 02.08.2011 of Shri Vidya Shankar Mishra, Sub-Engineer, Department of Water Resources, for revision of allocation under spouse policy, was considered by the State Advisory Committee in its meeting held on 23.01.2012.
