- The States/UTs an Regional Sports Boards are requested to consider entering their team for the above All India Civil Services Tournament. The entries may be sent in the prescribed performa (copy attached) direct to the contact officer/organizer indicated at para 14 with a copy endorse to CCSCSB on or before **10th February, 2017**.
- Please ensure that the entries are submitted within prescribed time limits, failing which organizer will not be responsible for accommodation and transport facilities. Information regarding Hotels etc. are available at sys.mizoram.gov.in Web Portal.
- List of players along with photocopy of their Identity Card should be authenticated by the authorized officer under his signature & seal.
- All the participants shall carry individual Identity Card/Identity Slip for verification of eligibility criteria by the Organizing Committee/Representatives of the Board at the venue of the All India Civil Services Tournament.
- Addresses, Telephone Numbers, E-mail Addresses may be indicated by the participating State/UTs/RSB's.
- Managers meeting are likely to be held on the evening of a day before the date of commencement of the tournament.

9. Every participating team may bring two flags representing their States/UT/Regional Sports Board with them.

10. It should be ensured that every member of the team report at the venue and participates in the tournament as scheduled. Failure to do so shall be treated as an act of indiscipline. All the participants shall maintain strict discipline on and off the venue of the tournament. **Any act of indiscipline/misbehavior/misconduct will attract the provision of CCS (Conduct) Rules since Government Employees are treated 'ON DUTY' during All India Civil Services Tournament.**

11. The information about rules and regulation, entry form, change in dates/venue/cancellation etc. about the AICS Tournament is available on our website i.e. www.persmin.nic.in. All the participants' teams are, therefore, requested to check from our website/organizers of the tournament about any possible change before starting their journey.


12. **It is further clarified that matches for 3rd Place (both in Team and Individual Events) must be organized in order to determine 3rd Place.**
