**RECOMMENDATIONS OF THE STATE ADVISORY COMMITTEE  
REGARDING FINAL ALLOCATION OF PERSONNEL OF THE FOREST  
DEPARTMENT (NON PFS) OF UTTAR PRADESH TO THE STATE OF  
UTTARANCHAL**

In accordance with section-76 of Uttar Pradesh Reorganization Act-2000 the State Advisory Committee, constituted by the Government of India for assisting in allotment of officer to the successor state of Uttar Pradesh and Uttaranchal, after having approved the tentative final list of officers belonging to the Forest Department (Non PFS-Class III Employees-Ranger Officers) of U.P. and after having invited representations from persons who might be affected by the aforesaid tentative final list, met on November, 18, 2003 to properly consider and finalize its recommendations. It was placed before the committee that out of 253, proposed personnel none of them have submitted representations.

After proper consideration and due deliberations, the committee makes following recommendation on the basis of information provided by the Forest department, U.P. regarding final allotment of personnel, pay scale wise -




