
The agenda/issues were discussed and decisions taken as follows:-

1. The State Advisory Committee considered the representations received from the personnel of Civil Police Constable cadre (Junior Most) under Home Department. After due consideration and deliberations, the State Advisory Committee recorded its recommendations separately. The recommendations of the Committee are enclosed for issuance of final allocation orders.

2. The Committee deferred the cases of Civil police constable (Junior most), who have filed writ petitions due to absence of representative of Administrative department. The Committee also directed to send letter to Chief Secretary, U.P. in this regard.

3. The Committee was informed that the name of Jai Prakash Singh was inadvertently mentioned in place of Shri Jai Prakash Sharma in the TFAL/for allocation to Uttaranchal. Accordingly the allocation orders were issued by DOPT. The Committee after considering the explanation given by Administration Department allowed to replace the name of Sri Jai Prakash Singh with Sri Jai Prakash sharma in TFAL. The Govt. of India may be requested to amend the orders accordingly.


4. The Committee considered the proposal of Hill sub-cadre personnel to allocate to Uttar Pradesh. Under the new policy issued on May 16, 2006 by Govt. of India, junior spouse allocated to Uttaranchal by virtue of being in the Hill sub-cadre will also follow his/her senior spouse in Uttar Pradesh. The Committee, accordingly allowed the following personnel of Hill sub-cadre to allocate them to Uttar Pradesh to join their senior spouse who are allotted to Uttar Pradesh :-


- (1) Dr. (Smt.) Kiran Singh W/O Dr. Tungveer Singh Arya Medical Officer, Pauri Garhwal.

5. The Committee considered the case of Sri Ramesh Chandra Sharma, Storeman, Civil Defence Deptt. under spouse policy. Since His wife Smt. Sadhna is Head Mistress in Hill sub-cadre and also in higher scale, Sri Sharma is, therefore, recommended for allowed to join his spouse in Uttaranchal under spouse policy.

6. The Committee considered the case of Smt. Govindi Devi, Health Supervisor under spouse policy. Since her husband is also in the same scale and working in Agricultural University in Patwadangar, Nainital on non transferable post, Smt. Govindi Devi is allowed to join her husband in Uttaranchal.

7. The Committee considered the case of Sri Devendra Kumar Singh, Chief Agricultural Officer in Hill sub-cadre. The kidney of his wife Smt. Seema Singh has been transplanted in S.G.P.G.I., Lucknow, the Committee deferred the issue to obtain the opinion of State Medical Board.

**RECOMMENDATIONS OF THE STATE ADVISORY COMMITTEE REGARDING  
FINAL ALLOCATION OF PERSONNEL OF CIVIL POLICE, DEPARTMENT OF  
HOME, UTTAR PRADESH TO THE STATE OF UTTARANCHAL**

**( Constable Cadre )**

In accordance with section-76 of Uttar Pradesh Reorganisation Act-2000, the State Advisory Committee constituted by GOI for assisting the allotment of personnel to the successor States of Uttar Pradesh & Uttaranchal, after having approved the Tentative Final Allocation List of personnel belonging to Civil Police, Uttar Pradesh and after having invited representation from persons who might be affected by the aforesaid Tentative Final Allocation List, met on June 16, 2006 to properly consider and finalise its recommendations. Total 100 representations were placed before the Committee. The main objection of the representation is as follows -

- (a) Being a permanent resident of Uttar Pradesh, reluctant to go to Uttaranchal.
- (b) Did not opt for Uttaranchal.
- (c) Due to family problem unwilling to go to Uttaranchal.
- (d) That they do not possess any immovable property in Uttaranchal.
- (e) That their children are getting education in Uttar Pradesh,

The views of the Civil Police, of Uttar Pradesh in respect of 100 representations were placed before the Committee. After proper consideration and due deliberations, the Committee make the following recommendations on the basis of information provided by the Home Department, Uttar Pradesh, regarding final allotment of employee.


The Committee deferred the case of Sri Saiyad Abbas (TFAL No. 2178) to confirm the status including separately of spouse.


