The Government of India, drawing powers conferred under Section 77 (2) of the AP Reorganisation Act, 2014, hereby allocates all the State Cadre employees of the Commissioner / Director for Commercial Taxes, Revenue Department, in the category of Deputy Commissioner of Commercial Tax, who, immediately before 02.06.2014, were working in connection with the affairs of Government of Andhra Pradesh and have been recommended for allocation to Andhra Pradesh / Telangana by the Advisory Committee vide Lr. - 2. Provided that this order will not come into effect in respect of any person who has obtained 'stay order' from a Court of Law against his allocation to any of the Successor State, till the time such stay order is vacated.
