Sir,

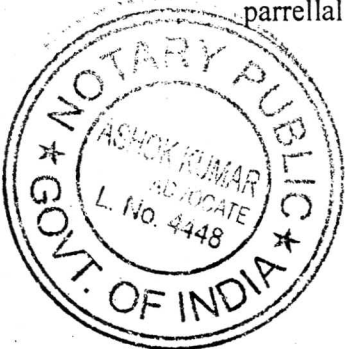
I am directed to refer to the above mentioned subject and to say that the Hon'ble High Court of Madhya Pradesh at Jabalpur directed Union of India on 12.04.2010 to pass fresh orders on allocation of the petitioner within two months from the date of filing of representation along with the certified copy of the order in W.P. No. 4428/2006 filed by Shri P.S.V. Nair, Asstt. Research Officer, Department of Water Resources.

2. On the basis of comments of Department of Water Resources, the representation dated 13.05.2010 of Shri P.S.V. Nair, Asstt. Research Officer, was considered by the State Advisory Committee in its 15th meeting held on 29.12.2010 and the Committee recommended his re-allocation to the State of Madhya Pradesh. The Central Government has accepted the recommendation of the Committee for revision of State allocation of Shri P.S.V. Nair, Asstt. Research Officer, from Chhattisgarh to Madhya Pradesh.

3. Shri Nair is hereby re-allocated to the State of Madhya Pradesh from the State of Chhattisgarh in partial modification of his allocation order No. 91/2002 dated 16.09.2002. The State Government may issue order of revision of allocation of Shri Nair parallel to this order under intimation to this Department.
