

(a): As per information received from the respective cadre controlling authorities, the requisite percentage is as given below:

(b): Requisite information relating to Scheduled Castes and Scheduled Tribes is given in the statement laid on the Table of the House.

Since the process of collection of data relating to Other Backward Classes has been started only in the year 2005, complete data as on date is not available in respect of Other Backward Classes.

(c): The requisite information is being collected.
