The undersigned is directed to say that the final results of the Stenographer Grade 'C' Limited Departmental Competitive Examination (LDCE) 2007 have been declared by the Staff Selection Commission on 30.01.2009. Based on the results of the examination, the SSC has recommended 34 (General-26, SC-05 & ST-03) candidates for appointment to the Stenographer Grade 'C' for the Select List Year 2007. Accordingly, 34 candidates are hereby allocated to various cadres of CSSS as shown in the Annexure to this O.M. 
