3. In terms of instructions contained in DoP&T's O.M. No.22011/4/98-Estt.(D) dated 12.10.1998 the appointments of retired officers need not be notified on their inclusion in the relevant Select List on promotion because promotions can take place prospectively and retired persons would not be available to avail of the actual promotion from a prospective date.


