The undersigned is directed to refer to this Department's O.M. of even number dated 25.9.2014 wherein the range of seniority for promotion from Stenographers Grade 'D' to Personal Assistants Grade of CSSS for the Select List Year-2014 was laid down and to say that on the basis of information furnished by the Cadre Units, it has been decided to nominate the PA(ad-hoc), whose names appear in the Annexure to this O.M., for appointment/promotion to the PA Grade of CSSS on regular basis on their inclusion in the Select List Year 2014(SQ).

- The concerned Cadre Units are also requested to ensure that the official concerned is relieved within 45 4. days from the date of issue of this O.M. to take up the new posting in the Cadre Unit allocated failing which the nomination order is liable to be cancelled by this Department. In case an official nominated against the Select List Year, 2014 refuses regular promotion, Cadre Units concerned may initiate action in terms of this Department's O.M. No.5/1/2008-CS.I(S) dated 8.4.2011 under intimation to this Department.
- As per the Cadre Training Plan for the officers/officials of CSSS issued vide O.M. dated 20.10.2011, successful completion of Level-I training programme of 3 weeks' at ISTM is mandatory for promotion to the PA grade. The aforesaid officials empanelled in the Select List of PA Grade 2014 have successfully completed the Level-I training programme held between 24.2.2014 to 14.3.2014 and 8.9.2014 to 26.9.2014.
