Note 3: Allowances and Perks:

(i) Dearness Allowance: Dearness Allowance (DA) rates in respect of posts at Sl. No. 1 to 9 will be as declared by Reserve Bank of India / Indian Banks Association from time to time. DA rate for November, December 2019 & January 2020 is 71.7% of Pay. Presently the revision of DA is quarterly, as under—
