ORDER

Reference is invited to this Department's Order No.4/6/2018-CS.I(D) Pt.I dated 11.12.2020, vide which Deputy Secretaries were promoted on adhoc basis against the existing vacancies of Director in the CSS Cadre. The officers so promoted on ad-hoc basis were directed to initially furnish their joining to the grade of Director of CSS on "as is where is" basis.

2. Attention is also invited to OMs No.5/10/2020-CS.I(U)(Pt.) dated 18.12.2020 and 19.12.2020 vide which it had been requested to ensure that officers promoted ad-hoc from Deputy Secretary to Director grade of CSS must join positively by 21st December 2020, failing which the promotion order with respect to non-joiner officers will be liable to be withdrawn, apart from debarment from ad-hoc promotions or other consequences.

3. On review, it has been found that out of the 146 officers in Cadre Units who were promoted ad-hoc to Director grade, confirmations in respect of joining by 03 officers still remain to be received.

4. As had already been impressed upon, such non-joining in Director grade is hampering the postings to fill up existing vacancies and hindering the mitigation of the problems being faced by the Ministries/Departments in smooth functioning of the governance machinery ; and thereby the very purpose for which these ad-hoc promotions were undertaken.

5. In the final resort, the concerned administrative Ministries / Departments are once again requested to confirm the joining or otherwise by the officers whose names figure in **Annexure** hereto, by 3:00 PM on 22nd December, 2020 without fail.

6. Further, it is to inform that in case of persistence of non-confirmation thereafter, the afore-mentioned order for ad-hoc promotion with respect to the non-joiner officers shall be liable to be withdrawn without any further notice ; and they will be deemed to be not willing to avail of the ad-hoc promotion to the grade of Director. Consequently, for all purposes they would continue as Deputy Secretary in the Ministry / Department where they are presently posted, inter alia for posting of Deputy Secretary level officers, orders for which are due to be issued separately for filling-up of vacancies across various Ministries / Departments.
