 - (i) The ad-hoc promotion shall not confer any right to continue in the grade indefinitely or for inclusion in the Select List for regular appointment or to claim seniority in the Selection Grade (Deputy Secretary) of the CSS.
 - (ii) Ad-hoc appointments may be terminated at any point of time without giving any reason thereof.
 - (iii) The appointment on ad-hoc basis will take effect from the date of assuming the charge of the post of Selection Grade (Deputy Secretary) in the Ministry/Department in which the officer has been posted.
 - (iv) The service rendered on ad-hoc basis in the Selection Grade (Deputy Secretary) would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
