ORDER

The Appointments Committee of the Cabinet has approved the proposal to increase the number of 40 JS (in situ) to 50 JS (in situ) of Central Secretariat Service (CSS) as a onetime measure in order to promote the remaining 10 officers of Senior Selection Grade Select List 2010 batch empanelled as JS for a period of maximum two years or till vacancies arise in the existing JS (in situ) due to retirement or the CSS empanelled officers are picked up as JS under Central Staffing Scheme, whichever is earlier. Accordingly, the following CSS Officers of Senior Selection Grade Select List 2010 are hereby appointed as Joint Secretary (in situ) in SAG Grade. The appointment shall be subject to and effective from the date of their assumption of charge in the Ministry/Department in which they are posted.
