
OFFICE MEMORANDUM

The undersigned is directed to refer to this Department's OM of even number dated 01.04.2015 and 16.04.2015 on the subject above. The concerned cadre units were requested to provide the Vigilance Clearance as on date, Major/Minor penalty certificate for the last 10 years, ACRs/APARs and disclosure certificate in respect of Sr. PPSs.

2. The concerned cadre units were also requested to ensure that the instructions as provided in this Department's OM No. 21011/1/2010-Estt.(A) dated 13.04.2010 have been complied with.
