Sir/Madam,

I am directed to refer to the subject mentioned above and to say that offer of appointment to 900 candidates on the basis of CGLE-2013 has since been issued by this Department. Now it has been decided to conduct further batches of Foundational Training at the following Training Institutes for all the remaining candidates yet to be issued offer of appointment.

2. The candidates may note that **training at all the ATIs will start in July, 2015 itself** and these would be the last of the batches for foundational training of recommended candidates of CGLE, 2013. No request for extension in joining shall therefore be considered. Failure to join the training as per the nomination by this Department will entail cancellation of the candidature.

3. All the candidates concerned are requested to exercise their preferences for undergoing the Foundational Training at any of the above mentioned ATIs. The candidates will be considered for training at ATIs as far as possible as per their preference, subject to availability of slots. However in case of lack of preferences for any particular ATI, this Department at its discretion will allot candidates and the nominated candidates will be required to report for

training at that ATI, irrespective of their preference. No communication for change of training centre will be entertained.

4. It is informed that attestation forms/medical examination report in respect of few candidates (list enclosed at Annexure) has however not yet been received in this Department despite a lapse of more than 3 months. They are advised to undergo medical examination at the District Civil Hospital, if they have not already done so and ensure that their medical examination report reaches this Department, by 15th July, 2015. Those candidates who are in Government service but their present offices have not forwarded their medical examination report obtained at the time of their appointment are also advised to undergo medical examination and furnish the report by 15.7.2015. It may be noted that these candidates were already advised vide this Department circular dated 20.6.2015 (uploaded on the website of this Department) to send the report by 1st July, 2015. No further opportunity to submit the report would be provided and failure to adhere to the deadline would be presumed not interested in joining and candidature will be cancelled without any further correspondence.
