OFFICE MEMORANDUM

Subject: Review of USSLS 2003-2008 reg.

The undersigned is directed to say that Select List for Grade-I of CSS i.e. Under Secretary was issued by this Department vide O.M. No. 5/16/2007-CS.I dated 25.8.2009 and USSLS 2004-2008 were issued vide O.M. dated 7.1.2010. After issue of these Select Lists, mistakes in calculation of vacancies in the USSLS came to notice as officers who were not in service on account of death, VRS, resignation, deputation, absorbed in other organisations etc. have been included in these USSLS. In addition, subsequent review of DSSLs for the years 2003 onwards also resulted in release of vacancies for US grade for these years.

2. In terms of Para 4.1 of the DOPT's OM No.22011/5/86-Estt.(D) dated 10.04.1989 (DPC guidelines), vacancies arising out of the above mentioned reasons should have been accounted for USSLS. In terms of DoPT's OM No. 22013/1/97-Estt.(D) dated 13.4.1998 Review DPC is required to be conducted inter-alia to rectify mistake of wrong calculation of vacancies.

3. In the meanwhile, in the OA filed by Smt. Garima Singh (OA No. 3278/2010), CAT, PB, New Delhi vide their order dated 9.5.2011 had directed this Department as under:

".....we would direct the respondents to prepare a fresh Select List for 2003 for promotion of Section Officers to the grade of Under Secretary by considering such of the direct recruits who may be short of eligibility service by up to two years as per the approved seniority list of Section Officers, and make promotions accordingly.

We reiterate that the eligibility criteria as regards direct recruits shall be reduced only by a period of two years, and only such of the direct recruits would be benefited who may be falling short of the eligibility criteria by two years, and not others.”


4. The aforesaid order of CAT has been challenged by this Department, UPSC and others in the Hon'ble High Court of Delhi in a batch of Writ Petitions which are still pending for adjudication. There is no stay on the orders of CAT. Pending litigation, the USSL-2003 has not attained finality and in view of this, we could not operate the list and subsequent USSLs for regular promotion to the grade of DS, adversely affecting cadre management.

5. After consultations with UPSC, DoLA, Govt. Counsel and Ld. ASG, it has been decided with the approval of the Competent Authority to review USSLs-2003 to 2008. While undertaking the review exercise, DR SOs of 1995 and 1996 batches who are presently included in USSL-2004 and USSL-2005 will be considered in terms of CAT's order dated 9.5.2011. It has also been decided to extend the order of CAT i.e. relaxation in the eligibility service for inclusion in USSL to the subsequent batches of DR SOs. The review of USSLs is, however, subject to pending litigation before HC, Delhi.

6. Accordingly, in the first instance, this Department will undertake the exercise of review of USSL-2003 in consultation with UPSC. Once review of USSL-2003 is completed, the subsequent USSLs will be reviewed. In this regard, the following three lists have been prepared:

- (i) Regular Under Secretaries as on 1.7.2003 i.e. Officers up to USSL-2002. In the list we have indicated the position with regard to deputation, VRS, expired cases or any other event which will have an impact on the vacancy for USSL-2003;
- (ii) Officers included in USSL-2003 but were on deputation, VRS, expired etc.
- (iii) Officers who were not clear from Vigilance angle on the date of original DPC. The list has been prepared to ascertain the date of issue of charge sheet/ date of initiation of prosecution, present status of disciplinary proceedings/ prosecution, whether any penalty was imposed / convicted / exonerated etc.

7. All the Ministries/ Departments are requested to confirm the position along with supporting documents by 27.1.2015. List at Sl.No. (iii) above is being forwarded separately to Ministries/ Departments concerned only.
