
OFFICE MEMORANDUM

Subject: Section Officers' Grade – Extension of Select List for the year 2003 against Seniority Quota - regarding.

The undersigned is directed to refer to this Department's O.M. of even number dated 12th August, 2008 on the above mentioned subject.
