OFFICE MEMORANDUM

Subject: Section Officers' Grade – Select List for the year 2006 against Seniority Quota.

The undersigned is directed to convey the approval of the competent authority to the Select List(Seniority Quota) of 2006 in the Section Officers' Grade of CSS(as per the list attached), which has since been prepared on centralised basis, based on the information received from the cadre units.

2. The size of the Select List 2006 (SQ) shall be as under:

3. While every effort has been made to incorporate the correct details of the officials w.r.t. their date of birth, place of posting etc., in case any discrepancy is noted, the same may be intimated to this Department for rectification at the earliest, latest by **15-3-2010.**

4. The total number of vacancies to be filled in the Select List 2006 against Seniority Quota is 115. The officials covered in the Select List may be promoted immediately subject to DPC and Vigilance clearance. All those officials who are included in the Select List are retained in their respective cadres on their promotion, within the sanctioned strength of the cadre in the SO's grade. Excess(+), if any, who cannot be adjusted in the respective cadre units due to non-availability of a vacancy in SO Grade, may be intimated to this Department to enable further necessary action, latest by 15.3.2010.


5. The cadre unit authorities are requested to take immediate action for appointment of officials who are declared fit for promotion by the DPC to the grade of Section Officer. The cadre unit authorities must ensure that no ineligible/unfit official is appointed to the grade. It may also be ensured that no vigilance case is either pending or contemplated against the officer being appointed.

UOI pending in CAT, Delhi , CWP No. 13352/2005 in the High Court of Delhi, OA No. 3294/2009 in CAT, Delhi and OA No. 2674/2009 in CAT, Delhi.
