As per Rule 19(2) of CSS(Amendment) Rules, 2010, “ if an officer is not relieved within forty-five days or such further period as referred to in sub-rule (1), the officer shall be ‘deemed’ to have been relieved by the Cadre-Unit in which he is working and thereafter the officer shall not be entitled to draw any salary and allowances for the period of such overstay from the Cadre-Unit from where the Cadre officer was transferred.”

Non-compliance of CSS Rules by concerned Section Officers/Cadre Units has been viewed very seriously by this Department and the Competent Authority has directed that the concerned Ministry/Department shall make arrangement to **relieve the officers mentioned above without further delay and latest by 08.03.2013.
