

VACANCY CIRCULAR

Sub: Filling up the post of two Non-Executive Members in National Council for Vocational Education and Training.

The Ministry of Skill Development & Entrepreneurship (MSDE), Government of India notified the National Council for Vocational Education and Training (NCVET) as a non-statutory regulatory authority, by merging the National Council for Vocational Training (NCVT) and the National Skill Development Agency (NSDA), on 5th December 2018 to function as an overarching regulator mandated to regulate both long and short-term vocational training in the country.


2. Applications are invited, in the given proforma, from the citizens of India for the two posts of Non-Executive Members in the National Council for Vocational Education and Training (NCVET).
3. Fees: A Non-Executive Member shall be entitled to receive remuneration of Rs. 6000/- (Rupees six thousand) likely to be revised, by way of sitting fee, as determined by the Central Government from time to time, for each meeting of the Council attended by him/her. A Non-Executive Member while on tour (including a journey undertaken to attend a meeting of the Council) shall also be entitled to travelling and daily allowances as applicable to highest class of Group 'A' service.
4. Eligibility: Applicants should be persons of ability, integrity and standing who have special knowledge of, and professional experience of not less than fifteen years in business management, human resource management, skill development, higher education, public administration or related fields.
5. Age limit and tenure: The Non-Executive Members shall hold office for a term of five years or until the age of sixty-five years, whichever is earlier. The applicant should not be more than 62 years of age as on the last date of receipt of application i.e. 31.03.2020

6. The Selection Committee reserves the right to suitably modify the eligibility & other criteria, if considered necessary and also to consider outstanding candidates who have not applied for the posts.

7. Application as per the given proforma along with one passport size photograph should be sent through proper channel to the following address in a closed cover superscribed with "Application for the post of Non-Executive Member, NCVET".
