The maximum age limit for appointment by deputation shall be not exceeding fifty six years as on the closing date of receipt of applications.

5. Departmental Officers in the feeder category who are in direct line of promotion will not be eligible for appointment on deputation. Similarly, deputationists will not be eligible for appointment on promotion. (Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department shall ordinarily not exceed 3 years).
