Subject: Zone of consideration for inclusion in Select List of Section Officers' Grade of CSS for the years 2012, 2013 and 2014 against Seniority Quota – regarding

The undersigned is directed to refer to this Department's OMs No.6/5/2015-CS-I(S) dated 06.02.2015, No.6/6/2015-CS-I(S) dated 09.02.2015 and No.6/7/2015-CS-I(S) dated 04.03.2015 vide which the zone of consideration for inclusion in Select List of Section Officers' Grade of CSS for the year 2012, 2013 and 2014 respectively were issued and subsequent reminders of even number dated 20.05.2015 & 01.06.2015.

2. However, the information in respect of the DPC recommendations for all the officers included in the zone for all three years, complete in all respects, and about the corrective action taken in respect of orders/notification issued in respect of retired officers or officers who have not yet qualified the Level B training, have not been received from majority of the cadre units. The status of information received/yet to be received from the cadre units is available in the attached statement.

2. The Cadre Units are, therefore, once again requested to conduct the DPCs in respect of all officers included in the zone, who are working in or retired from the Ministries/Departments under their control immediately and furnish the requisite information in the prescribed proforma to this Department to enable early finalization of Select Lists for these years. The corrective action taken in respect of orders/notifications issued, if any, of retired persons or officers who have not yet qualified the Level B training may also be intimated.
