
OFFICE MEMORANDUM

Subject: Posting on promotion to US grade on regular / ad-hoc basis – seeking options – reg.

The undersigned is directed to say that it is proposed to promote 15 officers on ad-hoc basis to US grade from the approved panel against the existing vacancies. In addition, posting of two officers on their inclusion in USSL-2014 is also to be decided.

2.
