**OFFICE MEMORANDUM**

**Subject: Non-functional Selection Grade (NFSG) in the grade of UDCs of CSCS-reg.**

The undersigned is directed to refer to this Department's O.M. No. 12/2/2015-CS.II(B) dated 16<sup>th</sup> November, 2015 vide which recovery order of NFSG of 211 officials were issued. Subsequently, Shri Uttam Dey Sarkar and 55 other officials of different cadre units have filed an O.A. No. 639/2016 before Hon'ble CAT, PB, New Delhi regarding the recovery of NFSG. Out of 56 officials, 5 officials have no recovery. The Hon'ble CAT vide order dated 02.03.2016 has passed the following order:-


***"In view of the prima-facie case, the respondents are directed not to revert the applicants nor affect any recoveries till further orders."***
