Subject:- Preparation of Common Seniority List(CSL) in the grade of JSA(erstwhile LDC) of CSCS as on 01-01-2016-reg.

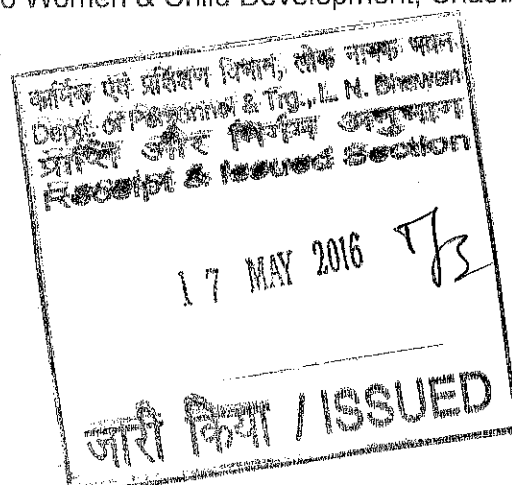
