- (vii) Convening of DPC by Env. & Forests, UPSC, MSME and Youth Affairs & Sports for PA for the Select List Year 2009.
- (viii) Completion of ACRs of PS up to SL Year 2000 (Gen) and 2002 (SC&ST).
