However, the total monthly consolidated fee of the retired employees employed on Contract basis shall not be more than Last Pay drawn by him calculated at the current rates of Dearness Allowance as per provisions of GFR as amended from time to time.

On appointment either on deputation basis or on contract basis, the engagement will initially be for a period of six months from the date of joining which can be extended further on the basis of requirement of the Commission and performance of the engaged person(s) upto the present term of the Commission i.e. 9.01.2018 as as may be decided by the Govt.




