**OFFICE MEMORANDUM**


Subject: Re-fixation of pay of officers following their placement in the appropriate Deputy Secretary Select List - Clarification - regarding

The undersigned is directed to state that vide this Department's OM of even no. dated 29.03.2016, order had been issued for inclusion of 21 SC/ST officers in the appropriate Selection Grade Deputy Secretary Select Lists (DSSSLs) by giving them the benefit of the third proviso to Rule 12(2) of erstwhile Central Secretariat Services Rules 1962. Inclusion of these officers in the earlier DSSSLs was only in modification of the original panel.

2. In continuation of the said OM dated 29.03.2016, it is stated that notional fixation of pay, as allowed to the officers included in the original panels, is also allowed to the following officers.

3. When the original panels were issued, the notional promotion was granted w.e.f. 1<sup>st</sup> July of the Select List year. Notional fixation of pay was also allowed w.e.f. 1<sup>st</sup> July of the select list year, with actual benefit from the date of their actual appointment. The terms of appointment viz. notional promotion and notional fixation of pay as allowed to the officers included in the original panel is also allowed to these officers. However, the actual benefit would accrue to them only from the date they actually functioned as Deputy Secretary. The re-fixation of pay of these officers may be done on the above lines.
