In case no communication is received by the stipulated date, the information as furnished in the list will be considered as final and further action will be taken accordingly. The officers to be considered for rotational transfer will be finalized after correction of data, if any. If option is not received by stipulated date, it will be presumed that the officer has no specific choice and posting will be decided by the Placement Committee accordingly.
