OFFICE MEMORANDUM

Subject:- Rotational Transfer of Director of CSS – regarding.

The undersigned is directed to refer to the Order No. 3/1/2017-CS.I(D) dated 27.09.2018 regarding promotion to the grade of Director, CSS. The existing Rotational Transfer Policy as contained in this Department's O.M. No. 21/2/2009-CS.I(P) dated 16th July, 2015; provides that on promotion, an officer will be posted out of the Ministry/ Department if he/she has served in the same Ministry/ Department in any capacity for a period exceeding the prescribed tenure for the promotion post.

2. Accordingly, a list of serving Directors who have completed the prescribed tenure as on 31.10.2018 and have more than two years in superannuation and are not exempted from transfer in terms of the RTP, has been prepared and is enclosed (**Annexure - I**).

3. Ministries/ Departments and officers concerned may check the information in the Annexure-I and bring to the notice of this Department if there is any discrepancy in the list, without any delay.

4. The officers concerned should also ensure that their data is complete in all respects in the web based cadre management system at cscms.nic.in. If the data is not complete, it should be first got updated in the system.

5. The officer listed at annexure-I are requested to exercise their option in the other Ministries/Departments as per RTP in the enclosed format at **Annexure-II** latest by **31st October, 2018** and send the same to Under Secretary CS-I(D), DOPT through e-mail (d.banerjee@nic.in). A statement showing the availability of vacancies at DS/Director level in various Ministries/Departments is enclosed as **Annexure III**. In case no communication is received by the stipulated date, the information as furnished in the list will be considered as final and further action will be taken accordingly. The officers to be considered for rotational transfer will be finalized after correction of data, if any. If option is not received by stipulated date, it will be presumed that the officer has no specific choice and posting will be decided by the Placement Committee accordingly.
