ORDER


Rotational transfer of Grade-I officers (Under Secretary) of CSS as indicated in the annexure are hereby ordered with immediate effect.

2. Ministries/Departments concerned shall comply with the transfer orders strictly and relieve the officers concerned at the earliest. Copy of the relieving orders and joining reports should be sent to this Department. No request for retention of any of the officers shall be entertained by this Department.

3. If an officer is not relieved within forty-five days of this order, in terms of Rule 19 of CSS Rules, 2009 (Notification dated 15.09.2010), the officer shall be deemed to have been relieved by the Ministry/ Department in which he is working and the officer concerned is also not entitled to draw pay and allowances from the current Ministry /Department beyond this stipulated period. If the officer concerned fails to join his new posting even on expiry of the forty-five days, he/she is liable to action as deemed fit by this Department.

4. A copy of this order be served on the officers concerned for their information and compliance.

5. If data for web based cadre management has not been furnished in respect any of the officers covered in this order, the same should also be furnished to this Department without any further delay.
