2. The Appointments Committee of the Cabinet has approved the following proposals of the Department of Personnel & Training (AV Division):-

- (i) Appointment of **Shri Ajay Bhatnagar, IPS (JH:1989)**, Joint Director CBI to the post of **Additional Director, CBI** on deputation basis for a tenure of **three years**, from the date of assumption of charge to the post, or until further orders, whichever is earlier;
- (ii) Appointment of **Shri Dharam Chand Jam, IPS (RJ:1991)**, Joint Director CBI to the post of **Additional Director, CBI** on deputation basis for a tenure up to his superannuation on **31.10.2023**, from the date of assumption of charge to the post, or until further orders, whichever is earlier;
- (iii) **Extension** in deputation tenure of **Shri Rakesh Aggarwal, IPS (HP:1994)**, Joint Director, CBI for a period of **two years** beyond 02.09.2020 i.e. from 03.09.2020 to 02.09.2022 (combined 7 years) or until further orders, whichever is earlier;
- (iv) **Extension** in deputation tenure of **Shri A.Y.V. Krishna, IPS (AM: 1995)** Joint Director, CBI for a period of **six months** beyond 17.07.2020 for completion of the investigation of IMA Scam Case or the time till leave of Hon'ble High Court of Karnataka is obtained for his relieving, or until further order, whichever event occurs the earliest, **in relaxation of the IPS Tenure Policy**; and,
- (v) **Extension** in deputation tenure of **Shri Vineet Vinayak, IPS (SK:1995)**, Joint Director, CBI for a period of **06 months** beyond 09.09.2020 tenure i.e. from 10.09.2020 to 09.03.2021 or till leave from the Hon'ble Supreme Court of India is obtained for his relieving or until further order, whichever event occurs the earliest, **in relaxation of the IPS Tenure Policy**.
