OFFICE MEMORANDUM

Subject: Debarment of Shri Neeraj Sinha, IPS(JH:87).

Shri Neeraj Sinha, IPS(JH:87) was approved for appointment as CVO in Central Warehousing Corporation (CWC), Delhi vide this Department's O.M. dated 04.08.2017. The Government of Jharkhand was also requested to relieve him with the direction to join his new assignment as CVO, CWC. Since, Shri Sinha did not join the assignment, the Government of Jharkhand, vide this Department's communication of even number dated 27.11.2017 was requested to bring the implications of not joining the assignment to the notice of Shri Sinha so that on a later date, he may not represent that the adverse consequences of not joining as CVO, CWC were not brought to his notice. It was also pointed out vide communication of even number dated 21.02.2018 that in case no reply was received or the officer did not join by 15.03.2018 or the Government of Jharkhand did not relieve him, this Department would go ahead with cancellation of his appointment and notify his debarment with its attendant consequences.


2. Since, Shri Neeraj Sinha, IPS(JH:87) has failed to join the post of CVO, CWC, Delhi in accordance with para C(xi) of CVO guidelines dated 28.04.2017, the approval conveyed to the aforesaid appointment is hereby **cancelled** and Shri Neeraj Sinha, IPS(JH:87) is debarred from all kinds of central deputation (including Central Staffing Scheme) for a period of 5 years w.e.f. 04.08.2017. In addition, he is also debarred from being given cadre clearance for any foreign assignment/consultancies abroad, during the period of debarment as per the extant policy. Shri Neeraj Sinha, IPS(JH:87), may accordingly be informed.
