This is regarding filling up the post of Financial Adviser in NCLAT under the Ministry of Corporate Affairs on deputation basis.

- 2. Officers of the rank of Deputy Secretary/Director level from the All India Services or any Organized Services of the Government of India, eligible for appointment under Central Starling Scheme are eligible for the post.
