**OFFICE MEMORANDUM**

***Subject: Additional charge arrangement for the vacant posts of CVOs in Ministry of Power.***

Ref: Ministry of Power's OM No. C-30019/36/2016-V&S dated 04.09.2018.

2. The Appointments Committee of the Cabinet has approved the following proposal:-

- i) Regularization of additional charge of the post of CVO, National Thermal Power Corporation Ltd. (NTPC), Delhi given to Shri V. K. Saxena, IRS(IT:84), CVO, Power Grid Corporation of India Ltd. (PGCIL), Delhi from 22.08.2016 and continuation of additional charge of the post for a period upto 30.11.2018, or till Shri Rajit Punhani, IAS(BH:91) takes charge as CVO, NTPC, whichever is earlier.
- ii) Regularization of additional charge of the post of CVO, North Eastern Electric Power Corporation Ltd. (NEEPCO), Shillong given to Shri Devendra Kumar Verma, IFoS(KL:86), CVO, Damodar Valley Corporation (DVC), Kolkata from 04.07.2016 and continuation of additional charge of the post for a period upto 03.07.2019, extendable coterminous with his tenure as CVO, DVC, or till the joining of a regular CVO in NEEPCO, whichever is earlier.
- iii) Regularization of additional charge of the post of CVO, Tehri Hydro Development Corporation of India Ltd. (THDC), Rishikesh given to Ms. Sunita Singh, IFoS(MH:87), CVO, Rural Electrification Corporation Ltd. (REC), Delhi from 06.04.2017 and continuation of additional charge of the post for a period till Shri Bhawani Prakash Gupta, IFoS(UD:92) takes charge as CVO, THDC.
