Subject : Scrutiny of the antecedents of persons recommended for Board level posts in PUBLIC SECTOR ENTERPRISES.

The undersigned is directed to say that a question for evolving a mechanism to ascertain and scrutinise the antecedents of persons recommended for Board level posts in public sector enterprises, has been examined by the Government. It has been decided that it would be primary responsibility of the administrative Ministry/Department concerned to ensure that the candidates, whose appointment as Functional Director/CMDs in public sector enterprises is recommended for being considered by the Appointments Committee of the Cabinet should be cleared from vigilance angle and that the Ministry/Department concerned should bring this fact specifically to the notice of Minister-in-charge. In respect of those persons, who are already holding Board-level positions and who have been recommended for higher Board-level positions, the vigilance clearance may be ascertained, besides other sources, from the Central Vigilance Commission. As regards the persons who are holding below Board-level positions in public sector enterprises, the CVO in the Ministry/Department concerned should be consulted, besides the CVO in the public sector enterprise where the candidate may be working for the present.

2. The Ministry of Industry (Department of Public Enterprises) may comply with the above mentioned guidelines while sending proposals to the Establishment Officer to the Government of India for being placed before the Appointments Committee of the Cabinet for its consideration.
