OFFICE MEMORANDUM

Subject:- Appointment to the post of Counsellor (Coord.), Embassy of India, Moscow under Ministry of Defence.

Reference:- Ministry of Defence's O.M. No. A-12018/1/2015-D(Est./Gp.I) dated 30/09/2016

The Appointments Committee of the Cabinet (ACC) has approved the appointment of Shri Saurabh Kumar, IFOS (AGMUT: 2003) to the post of Counsellor (Coord.), Embassy of India, Moscow vice Sh. P. Mohanty, IOFS (1987) for a period of 3 years from the date of assumption of charge of the post or until further orders, whichever is earlier.

2. It may be noted that the diplomatic equation of the officer i.e. Counsellor (with RG), will not be upgraded during the course of his posting abroad due to any reason such as revision of pay scale from a prospective or retrospective date, earning of annual increment(s) and promotion in parent cadre etc.

3. The Ministry of Defence is requested to convey his date of assumption of charge of the post of Counsellor (Coord.), Embassy of India, Moscow for information and records of this Department.

4. It may also be noted that the deputationist officer is deemed to have been relieved on the date of expiry of the deputation period unless the competent authority has with requisite approvals, extended the period of deputation, in writing, prior to its date of expiry. In the event of the officer overstaying for any reason whatsoever, he/she is liable for disciplinary action and other adverse Civil/Service consequences which would include the period of overstay not being counted for service for the purpose of pension and that any increment due during the period of overstay being deferred with cumulative effect, till the date on which the officer rejoins in his parent cadre. Proceedings for deemed resignation from service would also be initiated. This may be brought to the notice of the officer.
