#### OFFICE MEMORANDUM

Subject: Amendment to the provisions of rule 10 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965 regarding review of suspension.

The undersigned is directed to refer to the provisions of rule 10 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965 and to say that the provisions regarding deemed suspension have since been reviewed by this Department.

- The provisions in Rule 10 of CCS (CCA) Rules have been modified and amendment to the same have been notified in Notification No. GSR 105 dated 6.06.2007 published in the Gazette of India dated 16.06.2007.
- 3. As per the original provisions of rule 10 of the CCS (CCA) Rules, 1965, the provision for review within ninety days was applicable to all types of suspensions. However, in cases of continued detention, the review becomes a mere formality with no consequences as a Government servant in such a situation has to continue to be under deemed suspension. It has, therefore, been decided that a review of suspension shall not be necessary in such cases. Accordingly, a proviso has now been added to sub-rule(7) of the said rule 10 as follows:

"provided that no such review of suspension shall be necessary in the case of deemed suspension under sub-rule(2), if the Government servant continues to be under detention at the time of completion of ninety days of suspension and the ninety days period for review in such cases will count from the date the Government servant detained in custody is released from detention or the date on which the fact of his release from detention is intimated to his appointing authority, whichever is later."

4. In deemed suspensions under sub-rule (2), the date of order of suspension may be much later than the deemed date of suspension. With a view to making these provisions explicit, sub-rule (6) of the aforesaid rule 10 has now been amended to substitute the words "ninety days from the date of order of suspension" occurring therein with "ninety days from the effective date of suspension". Consequent upon this amendment, it would henceforth

be necessary to specifically indicate in the orders of suspension the effective date of suspension.

5. Sub-rule (7) of the aforesaid rule 10 stipulates says that "Notwithstanding anything contained in sub-rule (5)(a), an order of suspension made or deemed to have been made under sub-rule (1) or (2) of this rule shall not be valid after a period of ninety days unless it is extended after review, for a further period before the expiry of ninety days." Sub-rule (5)(a) of the aforesaid rule 10 has, therefore, now been amended to read as follows:-

"subject to the provisions contained in sub-rule (7), an order of suspension made or deemed to have been made under this rule shall continue to remain in force until it is modified or revoked by the authority competent to do so."

Consequently, the words "Notwithstanding anything contained in sub-rule (5)(a)" stated in sub-rule(7) of Rule 10 have become redundant and have, therefore, been deleted.

- 6. In so far as persons serving in the Indian Audit and Accounts Department are concerned, these amendments have been made in consultation with the Comptroller and Auditor General of India.
- 7. All Ministries/Departments are requested to please bring the aforementioned amendments of rule 10 of the CCS (CCA) Rules, 1965 to the notice of all disciplinary authorities under their control and ensure that review of the orders of suspension is conducted strictly in conformity with the amended provisions thereof.

- 1. (1) इन नियमों का नाम केन्द्रीय सिविल सेवा (वर्गीकरण, नियंत्रण तथा अपील) संशोधन नियमावली, 2007 है।
  - (2) ये सरकारी राजपत्र में इनके प्रकाशन की तारीख से लागू होंगे।
- 2. केन्द्रीय सिविल सेवाएं (वर्गीकरण, नियंत्रण तथा अपील) नियमावली, 1965 में नियम 10 में :-
- (i) उप-नियम र में खण्ड (क) के स्थान पर निम्नलिखित खण्ड प्रतिस्थापित किया जाएगा, अर्थातु:-
- "5 (क) उप-नियम (7) में दिए गए प्रावधानों के अध्यधीन इस नियम के तहत् किया गया अथवा किया गया समझा जाने वाला कोई निलंबन आदेश तब तक लागू रहेगा जब कि इसे संशोधित करने अथवा रह करने के लिए सक्षम प्राधिकारी द्वारा ऐसा कर नहीं दिया जाए।"
- (ii) उप-नियम (6) में "निलम्बन के आदेश की तारीख से 90 दिनों की अवधि समाप्त होने से पूर्व" शब्दों के स्थान पर "निलम्बन की प्रभावी तारीख से 90 दिन की अवधि समाप्त होने से पूर्व" शब्द प्रतिस्थापित किए जाएंगे।
- (iii) उप-नियम 7 के स्थान पर निम्नलिखित उप-नियम प्रतिस्थापित किया जाएगा, अर्थात् :--
  - "(7) इस नियम के उप-नियम (1) अथवा (2) के तहत किया गया अथवा किया हुआ माना गया निलम्बन का कोई आदेश 90 दिन की अविध के पश्चात् वैध नहीं रहेगा जब तक कि इसे समीक्षा के बाद, 90 दिन की अविध समाप्त होने के पूर्व, आगे की अविध के लिए और बढ़ा नहीं दिया जाए।:

- G.S.R. 105.—In exercise of the powers conferred by the proviso to article 309 and clause (5) of article 148 of the Constitution and after consultation with the Comptroller and Auditor General of India in relation to persons serving in the Indian Audit and Accounts Department, the President hereby makes the following rules further to amend the Central Civil Services (Classification, Control and Appeal), Rules, 1965, namely:—
- (1) These rules may be called the Central Civil Services (Classification, Control and Appeal) Amendment Rules, 2007.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- In the Central Civil Services (Classification, Control and Appeal) Rules, 1965, in rule 10:—
  - (i) In sub-rule (5), for clause (a), the following clause shall be substituted, namely:
- "(5) (a) Subject to the provisions contained in subrule (7), and order of suspension made or deemed to have been made under this rule shall continue to remain in force until it is modified or revoked by the authority competent to do so."
  - (ii) In sub-rule (6), for the words "before expiry of ninety days from the date of order of suspension", the words "before expiry of ninety days from the effective date of suspension" shall be substituted.
  - (iii) For sub-rule (7) the following of sub-rule shall be substituted, namely:—
- "(7) An order of suspension made or deemed to have been made under sub-rules (1) or (2) of this rule shall not be valid after a period of ninety days unless it is extended after review, for a further period before the expiry of ninety days:

Provided that no such review of suspension shall be necessary in the case of deemed suspension under subrule (2), if the Government servant continues to be under suspension at the time of completion of ninety days of suspension and the ninety days period in such case will count from the date the Government servant detained in custody is released from detention or the date on which the fact of his release from detention is intimated to his appointing authority, whichever is later."
