
NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 and clause (5) of article 148 of the Constitution, and after consultation with the Comptroller and Auditor-General in relation to persons serving in the Indian Audit and Accounts Department, the President hereby makes the following rules further to amend the Fundamental Rules, namely:-

- (1) These Rules may be called the Fundamental (1st Amendment) Rules, 1986.
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. In sub-rule (2) of rule 31 of the Fundamental Rules, for the existing first proviso, the following shall be substituted:

"Provided that such lower officiating post was held on a regular basis or would have been so hold, but for the officiation on a regular basis in a higher cadre or ex-cadre post."
