Notification

G.S.R. In exercise of the powers conferred by the proviso to article 309 and clause (5) of article 148 of the Constitution and after consultation with the Comptroller and Auditor General of India in relation to the persons serving in the Indian Audit and Accounts Department, the President hereby makes the following rules further to amend the Fundamental Rules, 1922 namely:-

1. (1) These rules may be called the Fundamental (Amendment) Rules, 2000.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In rule 22 of the Fundamental Rules, 1922, in sub-rule I, in item (a), for the words "Save in cases of appointment on deputation to an ex-cadre post, or to a post on *ad hoc* basis" the words "**Save in cases of appointment on deputation to an ex-cadre post, or to a post on *ad hoc* basis or on direct recruitment basis**" shall be substituted.
