OFFICE MEMORANDUM

Subject:- Payment of Leave encashment under Rule 39-C of CCS (Leave) Rules- Additions to the list of persons to whom cash equivalent of leave salary is payable on the death of a Government servant.

The undersigned is directed to say that this Department has been considering the question as to whom the cash equivalent of leave salary should be payable on the death of a Government servant while in service or after retirement etc. but before actual receipt of the amount in cases where none of the claimants listed under Rule 39-C (i) to (ix) of CCS (Leave) Rules is available. It has now been decided that in such cases, the cash equivalent of leave salary may be paid to the eldest surviving married daughter and failing that to the eldest child of a pre-deceased son of the deceased Government servant.

2. These orders take effect from the date of issue.
3. In so far as persons serving in the Indian Audit and Accounts Department are concerned, this OM issues with the concurrence of the Controller and Auditor General of India.
4. Formal amendment to the CCS (Leave) Rules will follow.


