

OFFICE MEMORANDUM

Subject:- Age-concession to personnel retrenched from the Chukha Hydel Project Authority in Bhutan.

The undersigned is directed to say that the question of providing facilities to the directly recruited employees of Chukha Hydel Project Authority in Bhutan who are rendered surplus on completion and commissioning of the project and consequently retrenched by the authority has been carefully considered by the Government and it has been decided to allow them age-relaxation to the extent of regular service rendered by them with the Authority for purposes of appointment to Group 'C' and 'D' posts under the Government of India on the basis of certificate issued by that Authority regarding the period of regular service rendered by them in each individual case. This relaxation will be available for a period of ten years from the date of issue of these instructions

- 2. As regards appointment to Group 'A' and Group 'B' posts/services, the matter is separately under consideration.
- 3. Ministry of Finance etc. are requested to bring the contents of this O.M. to the notice of recruiting authorities under their administrative control.






