ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following rules further to amend the Government of India (Transaction of Business) Rules, 1961, namely:-

- 1. (1) These rules may be called the Government of India (Transaction of Business) Amendment Rules, 2010.
 - (2) They shall come into force at once.
- 2. In the Government of India (Transaction of Business) Rules, 1961, in the Third Schedule, for serial numbers 39 and 41 and the entries relating thereto, the following serial numbers and entries shall be substituted, namely:
