Your kind attention is invited to this Departments DO letter of even number dated 05.10.2017 requesting you to take expeditious action for amendment of RRs for the posts of Stenographer grade 'C' and 'D' and bring it in conformity with the guidelines issued by DoP&T vide OM No.AB-14017/48/2010 dated 31.12.2010.

2. The Staff Selection Commission (SSC) has conveyed that the recruitment rules in respect of the post of Stenographer grade 'C' and 'D' under the Ministries/Departments , as per list attached, are in deviation with the guidelines of DoP&T particularly in respect of the 'Age' and 'Educational Qualification' criteria. This has created a complex and difficult situation for the Commission to undertake recruitment for such organisations.

3. I would therefore request you to look into the matter and take urgent steps for notification of amendment in the recruitment rules and intimate regarding the same to the Commission.
