

Shri Anirudha Rout is also entitled to and assigned **1995** as his year of allotment taking into account his completed years of service and weightage in the State Civil Service in terms of Rule 3(3)(ii) of the IAS (Regulation of Seniority) Rules, 1987.

5. For the purpose of inter-se seniority, Shri Anirudha Rout shall be placed below Shri Kishore Chandra Barik IAS (SCS:1995) and above Shri Biswajit Mishra , IAS (SCS:1995).
