**OFFICE MEMORANDUM**

**Subject: Reassessment of CVO positions in CPSEs and the pay, incentives, allowances etc. related issues.**

The undersigned is directed to refer to the minutes of the meeting of the Selection Committee held on 24<sup>th</sup> June, 2015 and to say that a Committee has been formed under the chairmanship of Additional Secretary(S&V) to consider the issues related to reassessment of CVO positions in CPSEs and review of the extra pay, incentives, pay structure and allowances etc. of CVOs in CPSEs.

2. All Ministries/Departments are requested to furnish the following information about the CPSEs under their control within 15 days of receipt of this O.M.:-

- i. Whether full time CVO is required in particular organization.
- ii. Whether the post of CVOs of two or more organizations can be clubbed together.
- iii. Whether the post of CVOs is required to continue with the current posts or wishes to upgrade/downgrade or to abolish the posts in view of the workload and requirement of vigilance related matters.
- iv. Staff strength and volume of vigilance work involved in the CPSEs, turnover of organizations in last 5 years etc.
