**OFFICE MEMORANDUM**

Subject: Appointment of Smt. Meenakshi Mishra, IA&AS(83) to the post of Chief Vigilance Officer in the Security, Printing & Minting Corporation of India Limited (SPMCIL) under the Department of Economic Affairs.

2. The Appoinement Committee of the Cabinet has approved the appointment of Smt. Meenakshi Mishra, IA&AS(83) as Chief Vigilance Officer in the Security, Printing & Minting Corporation of India Limited. The officer will have the option to draw her pay in the pay scale of Joint Secretary to the Government of India plus deputation allowance, if admissible, or pay of the post.
3. On her appointment as Chief Vigilance Officer in the Security, Printing & Minting Corporation of India Limited, she would be eligible for an initial tenure of three years which is extendable upto 31.5.2017 i.e. the date of her superannuation, with the prior approval of the Central Vigilance Commission and the Department of Personnel & Training.
4. The appointment of Smt. Meenakshi Mishra, IA&AS(83) to the aforesaid post shall be effective from the date he assumes the charge of the post.


