**OFFICE MEMORANDUM**

**Subject: Appointment of Shri A. K. Poddar, IPoS (87), as Chief Vigilance Officer in the Container Corporation of India(CONCOR), New Delhi.**

Reference: Ministry of Railways, Railway Board's O.M. No. 2010/E(O)II/39/5 dated 05.03.2013 on the subject mention above.

2. The Appointment Committee of Cabinet has approved the appointment of **Shri A. K. Poddar, IPoS (87)** as Chief Vigilance Officer in the Container Corporation of India (CONCOR), New Delhi under the Ministry of Railways. The officer will have the option to draw his pay in the pay scale of Joint Secretary to the Government of India plus deputation allowance, if admissible, or pay of the post.

3. On his appointment as Chief Vigilance Officer in the Container Corporation of India (CONCOR), New Delhi, Shri A. K. Poddar, IPoS (87) would be eligible for an initial deputation tenure of three years, which is extendable up to a further period of two years in the same CPSE (total 5 years) with the prior clearance of CVC or up to a further period of three years on transfer to another CPSE on completion of initial tenure of three years in the previous CPSE.

4. The appointment of Shri A. K. Poddar, IPoS (87) to the aforesaid post shall be effective from the date he assumes the charge of the post, or until further orders, whichever is earlier.




