**OFFICE MEMORANDUM**


Subject: Appointment of Shri Rajesh Kumar Agerwal, ITS(93) to the post of Chief Vigilance Officer (CVO) in the Bird Group of Companies, Kolkata.

Reference: Ministry of Steel's O.M. No. 27(3)/2012-V&R dated 17<sup>th</sup> December, 2012 on the subject mentioned above.

2. The Competent Authority has approved the proposal of the Ministry of Steel for appointment of Shri Rajesh Kumar Agerwal, ITS(93) to the post of Chief Vigilance Officer in Bird Group of Companies, Kolkata. The officer will have the option to draw either the pay of the post or pay in the parent cadre plus deputation (duty) allowance thereon plus personal pay, if any.

3. On his appointment as CVO, Shri Rajesh Kumar Agerwal, ITS(93) will be entitled for initial deputation tenure of three years in the Bird Group of Companies, Kolkata, which is extendable for a further period of two years in the same organization, with the prior concurrence of the Central Vigilance Commission and Department of Personnel & Training.

4. The appointment of Shri Rajesh Kumar Agerwal, ITS(93) to the aforesaid post shall be effective from the date he assumes the charge of the post.
